WHEREAS, the Tribal Council further extends an invitation to Florida State University and its officials to continue their relationship and collaborate on the development of logos and nicknames that all members of the Seminole Tribe of Florida and officials and students of Florida State University can be proud; and

WHEREAS, the Tribal Council of the Seminole Tribe of Florida is otherwise full advised.





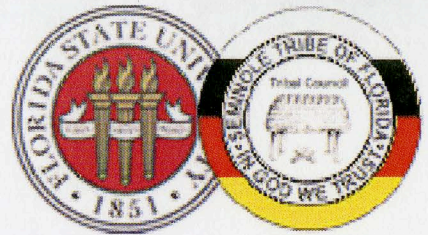
